SUMMARY REPORT
BRICKLAYERS LOCAL 8 PENSION FUND

November 24, 2025

This is a summary of certain information in the Annual Report of the **Bricklayers Local 8 Pension Fund** (the Plan) for the Plan Year May 1, 2024 through April 30, 2025.

As required by ERISA Section 104(d), the following information is provided with respect to the 2024 (April 30, 2025) Plan Year:

1. The hourly contribution rate in effect during plan year May 1, 2024 to April 30, 2025 was \$8.00 per hour.
2. Vested participants are entitled to a normal pension benefit at age 60. The benefit is determined by multiplying the participant's years of credited service by \$74.
3. The number of employers obligated to contribute to the Plan during plan year ended April 30, 2025 was 37.
4. The following employers contributed more than 5% of the total contributions to the Plan for plan year ended April 30, 2025:

The Rug Shop Inc.

5. The number of participants under the Plan on whose behalf no contributions were made by an employer as an employer of the participant for the plan year and each of the two preceding years is as follows:

6. The Plan's actuary certified that for Plan year beginning May 1, 2024, the Plan is not endangered, seriously endangered or critical and had a funded ratio of greater than 80% (green zone).
7. No employers withdrew from the Plan during the 2024 (April 30, 2025) Plan Year.

8. The Plan did not receive a transfer of assets and liabilities during the Plan Year, nor was it the subject of any merger. The Plan did not use the shortfall method (as such term is used in Section 305 of ERISA).
